## **ACCIDENTS**

No damage estimate of the building is available at this time. The vehicle was a total loss. Zitzow was transported to Hancock County Memorial Hospital. Charges are pending at this time.

On 06/11/2017 at 9:11 an accident was reported to the police department. A 2017 Toyota pickup owned by Peter John fox of Leland, IA was struck by a 2008 Toyota Sienna driven by Sara Pardoe, age 41 of Forest

City while it was parked on Woodland Drive. Damage to the pickup was estimated at \$3000. No injuries were reported at the time of the accident.

On 06/14/2017 at 3:10 PM a two vehicle accident was reported at the intersection of Hwy 69 S and South 4<sup>th</sup> Street. Involved in the accident were; Virgil Louis Ort, age 51 of Clear Lake, IA driving a 2010 Ford Fusion and Randy Wunschel of Webster City, IA driving a 2001 Ford F150 pickup. No injuries were reported at the time of the accident. Damage was estimated under \$1500.

On 06/16/2017 at 1:51 PM an 2016 Dodge Dart owned by Forest & Barbara Thompson of Forest City was struck while it was parked at Sid's Gas & Groceries. A 2012 FMC Sierra driven by Steven Thomas Rusley, age 53 of Lake Mills, IA struck the Thompson vehicle and left the scene. Damage was estimated under \$1500 and Rusley was charged with Leaving the Scene of an Accident.
